## Why Bermuda?

#### 1. POLITICAL STABILITY

Bermuda is a democratic, self-governing British Overseas Territory, with a political system that provides stability and consistency. Respected worldwide, its government is known for a low-bureaucracy approach to business and historically strong support for the financial services industry. That environment enables corporate commitment to the jurisdiction and the ability for long-term financial planning by investors.

#### 2. LOCATION & ACCESS

Located 650 miles (1,000 km) east-southeast of Cape Hatteras, North Carolina, Bermuda has daily direct flights to London, Toronto and US gateway cities—less than a two-hour flight from New York. Conveniently, both the island's commercial airport and executive private jet terminal offer the advantage of US Customs & Immigration pre-clearance on departure, shortening travel time.

#### 3. CONVENIENT TIME ZONE

The jurisdiction has a favourable Atlantic Time zone (GMT -4 hours), falling between North America and Europe.

#### **4. QUALITY LIFESTYLE**

The island's enviable standard of living includes excellent education, a sophisticated network of telecommunications, access to world-class healthcare, and sub-tropical physical beauty. Bermuda's attractions cater to every taste and preference with top-rated restaurants, world-famous beaches, championship golfcourses, modern superyacht marinas and boating services, a UNESCO heritage site, art galleries, myriad watersports, and the world's northernmost coral reefs.

#### **5. LOW-TAX DOMICILE**

A tax-neutral jurisdiction,
Bermuda has no income,
capital gains or corporate
taxes. Its consumption-based
system does levy payroll
tax, import duties, social
insurance, and custom duties
on goods and services—a
major component of the
island's tax revenues.
Bermuda's unique tax system
was designed to support its
own infrastructure.

#### **6. TWO CURRENCIES**

Bermuda's dollar is held on par with the US dollar, allowing Bermudian and American currencies to be used interchangeably on the island.

#### 7. TOP TALENT

Bermuda is home to worldclass expertise across multiple business sectors. Leading (Big Four) accounting and audit firms, highly-qualified financial advisers, corporate and private client lawyers, IT specialists, actuaries, (re)insurance underwriters, brokers, fund administrators, and support services all can be found within the two-square-mile parameters of the City of Hamilton. #### 8. LEGAL LEGACY

Bermuda's legal system marks its 400th anniversary in 2016. With courts dating back to 1616, the island uses English Common Law, with recourse to the UK Judicial Committee of the Privy Council.

Bermuda is respected worldwide for its strong record on compliance and tax-transparency. The island adheres to the highest standards of US and UK antimoney laundering (AML) and anti-terrorist financing (ATF) requirements, and has no banking secrecy laws. The island is globally recognised for more than 91 treaty partnerships and its regulator's top-quality supervisory system.

## **Living in Bermuda**

Bermuda is one of the most luxurious and popular destinations in the world, and recent updates to the island's laws have made it easier for high-net-worth individuals to live here. Anyone over the age of 18, of good character and conduct and with sustainable means or annual income, can take advantage of more flexible immigration options now available.

**PERMISSION TO RESIDE ON AN ANNUAL BASIS**—allows individuals to live on the island for a year.

**RESIDENTIAL CERTIFICATE**—gives individuals the right to live indefinitely in Bermuda.

Employment in Bermuda is not permitted under either of these categories. The Department of Immigration requires a completed application form and documentation relating to identity, character and financial means of the applicant.

**WORK PERMIT**—allows a person to live and work in Bermuda for a specific period of time up to five years. Granted via an employer, high-net-worth individuals hoping to work while in Bermuda should consider establishing a company in Bermuda to qualify for permits of under this scope.

**PERMANENT RESIDENT CERTIFICATE** (PRC) gives the right to live and work in Bermuda indefinitely. Through the Incentives for Job Makers Act 2013, senior executives of designated companies can apply for PRC if they meet certain criteria.

## Buying island property

There are a number of highly desirable private homes and condominiums available for rent or purchase by non-Bermudians, and leading real-estate agencies to facilitate the process.

Under Bermuda law, a minimum purchase value for international purchasers is about \$3.25 million for private homes, or \$700,000 for condos. Licence fees amount to eight percent of the purchase price for private homes, and six percent for condominiums.

International buyers may also buy property in developments designated as hotel residences and tourist accommodation.
